## Job Title: Grounds Technician

**SUMMARY**: Participates in maintaining grounds by mowing, edging, trimming shrubs, and watering lawns, applying herbicide and landscaping flower beds.

**ESSENTIAL DUTIES AND RESPONSIBILITIES:** Include the following. Other duties may be assigned.

Trims and edges around walks, flower beds, and walls.

Prunes shrubs and trees to shape and improve growth or remove damaged leaves, branches, or twigs.

Sprays lawn, shrubs, and trees with fertilizer, herbicide, and insecticides.

Cleans grounds and removes litter, Rakes and bags or burns leaves.

Shovels snow from walks and driveways.

Spreads salt on public passage ways to prevent ice buildup.

Plants grass, flowers, trees, and shrubs.

Waters lawn and shrubs, cleans out drainage ditches and culverts.

Sharpens tools such as weed cutters, edging tools, and shears.

Makes minor repairs on equipment such as lawn mower, spreader, and snow removal equipment.
